



Indiana Grand Race Course Stakes Nomination Form

*** Important Information Regarding Existing Out of Competition Rules

All horses nominated to stake races will be eligible for out of competition testing from the day of nomination. Several drugs were added to Out of Competition Testing including Cobalt, Zilpaterol, Ractopamine or any similar agent. If you have any questions about any of these rules, please refer to Indiana Code 71 IAC 8.5-2-5 and 71 IAC 8.5-3-4.

How This Affects You:

- Once a horse is nominated to a stake race, he WILL be in the pool of horses used for selection of Out of Competition Testing.
- If owner/trainer is contacted & notified their horse has been selected for Out of Competition Testing, that horse must be produced at track by the time provided by the IHRC.
- If the horse is not brought to the race track within the allotted time, the horse will be ineligible to race in Indiana for one year.
- Current trainer must be named at time of nomination - If there is a change of trainer at any time, the new info must be forwarded to the QHRAI immediately.

If a nominated horse becomes lame, sick or for any other reason will NOT run in the trials or finals, he must be officially scratched through the QHRAI

(prior to being contacted by IHRC) or he will remain eligible for ALL Out of Competition Rules. All nomination payments must include the nomination form & all sustaining payments must include the sustaining forms.

All Fields must be filled out completely & accurately. Missing or Incomplete forms will be returned & any money paid during this transaction will be refunded.

-By signing and submitting this stakes nomination form, the owner & trainer is hereby agreeing to abide by Indiana Horse Racing code.

Once this nomination is received by QHRAI, you will receive a reminder for next payment date and a list of nominated horses. Sustaining payments must be submitted on time whether or not you receive this reminder. Nominations and sustaining payments will be added to the stakes purses.

A 20% marketing and administration fee will be withheld from all open stakes nomination and sustaining payment.

*For Races with trials: The top 10 fastest qualifiers from trials will remain eligible for the stake. Races will be run as many times as deemed necessary - fields limited to 10 starters. If less than 14 horses enter back into the trials, the trials will be cancelled and moved to the final, with horses having the highest 2016-2017 earnings preferred. In order to be eligible for a full refund of payment, you must enter finals and fail to draw into finals.

*On High Money Earning Stakes (Indiana Grand Classic, Bradford Stake, Speed Sale Futurity, Indiana Championship)

If nomination is missed then the nomination fee of \$100 plus \$500 late fee must be postmarked by the sustaining payment date.

*On High Money Earning Stakes (Born Runner and Hoosier Park Classic) double the missed nomination plus sustaining payment and postmarked by sustaining payment date. On high money earning stakes the sustaining fee only will be refunded if failure to draw into the race.

*On stakes with trials - if nomination is missed- double the missed nomination plus the first sustaining payment. Must be postmarked by the sustaining payment date.

*On these open races: Indiana Grand QHRAI Derby, Heartland Futurity, Governors Stake, QHRAI Derby- Late pay after first sustaining payment is double missed payments plus \$5,000 plus 2nd sustaining payment. Must be postmarked by the sustaining payment date. (Note: these races have two sustaining payments due)

*When payment due dates fall on a holiday or Sunday, payments will be due, postmarked the following business day.

*Nominations & sustaining payments immediately become part of the financial structure of the race and are non-refundable.
